## Announcement of the Results of FY 2022 Survey on Technical Intern Training Program

- After returning to their home countries, 92.0% of the technical intern trainees answered that what they learned during the technical intern training period was useful -

The Organization for Technical Intern Training has conducted the survey below and summarized the results.

Based on the results of this survey, the Organization for Technical Intern Training will continue to ensure appropriate and smooth operation of the technical intern training program and to deepen the understanding of the program to the people concerned.

### 1. Technical Intern Trainees Follow-up Survey after Returning Home Countries (questionnaire for technical intern trainees)

This survey has been conducted every fiscal year since FY2018 to ascertain the employment status and changes in job positions after returning to Japan, as well as the utilization of skills, technology, and knowledge acquired in Japan, etc., of technical intern trainees who have completed technical intern training and have returned to their home countries.

Because many former trainees were unable to return to their home countries in FY2021 and FY2022 due to the impact of the new type of coronavirus infection, former trainees who were unable to return to their home countries and are currently residing in Japan under the "Designated Activities" status are also included as survey targets.

The survey for FY2022 covered 31,271 technical intern trainees who had completed the technical intern training and had returned or were scheduled to return to their home countries between September 1 to December 31, 2022, and whose nationalities were Vietnam, China, Indonesia, the Philippines, and Thailand. 7,648 of these responses were valid. Of these, 4,495 respondents, or 14.4% of those surveyed and 58.8% of the valid responses, indicated that they have not returned to their home countries.

### 2. Survey on Assistance to Technical Intern Trainees after Returning Home Countries (questionnaire for supervising organizations, etc.)

This survey studies the employment status of the technical intern trainees who returned to their home countries in FY2021, job/skill transfer support and acquisitions of skills, etc. during the technical intern training for supervising organizations and implementing organizations of individual enterprise-type training (hereinafter referred to as "supervising organizations", etc.).

Out of 3,116 supervising organizations, 2,810 were valid responses.

## 【Key points of survey results】

Follow-up survey of technical intern trainees after returning to home countries  
(The following information is the result of excluding responses of "have not returned home"  
from the valid responses.)

- 92.0% of the respondents answered that what they learned during the technical intern training period was "useful".
- As for the specific details that were useful, "Technical skills acquired" was the highest at 78.9%, followed by "Workplace discipline" at 66.0% and Experience living in Japan" at 65.4%.
- In relation to the employment status after returning to their home countries, 33.6% of the respondents answered "employed and working" (17.0%), employed and scheduled to work (5.9%), or started a business (10.7%).
- 66.5% responded that their specific job duties are "same as the training" (45.8%) or "same type as the training" (20.7%).

Survey on Assistance to Technical Intern Trainees after Returning Home Countries

- In relation to the employment status after returning to their home countries, 51.6% of the respondents answered "employed and working" (40.7%), employed and scheduled to work (5.0%), or started a business (5.9%).
- 55.7% responded that their specific job duties are "same as the training" (31.1%) or "same type as the training" (24.6%).
- 73.2% of the supervising organizations answered that they provided assistance for promoting skill transfer of former trainees.
  - As for the specific details, "Issuance of Certificate of Completion of Technical Intern Training, Certificate of Employment, etc. in Japan" was the most common at 81.0%, "Consultations regarding employment and entrepreneurship after returning home countries" was 36.2%, followed by "Information and recommendation of employment after returning home countries" at 32.5%.
- Currently, 98.6% of the supervising organizations answered that "they are proceeding according to the technical intern training plan" regarding technical intern trainees residing in Japan.
