- (1) When someone from your company abuses, threatens, or harasses you
- (2) When someone from your company doesn't abide by the law
 - They make you do work that is not in accordance with your technical intern plan
 - They don't pay you
 - They take away your residence card and/or passport
 - They limit you from going out, having fun, or being in a relationship
 - They threaten to send you back to your country even though you still have time remaining on your technical internship
 - Foreign nationals who have overstayed their visas are working
- (3) When someone from your company does not abide by your contract
